<b>ALLOWANCES AND ENTITLEMENTS FOR POST OF DEPUTY DIRECTOR:</b>			
<b>Living Allowance</b>	<b>US\$ 1540.00</b> (US Dollar One Thousand five hundred forty) per month (50 % US Dollar & 50 % PKR). Deputy Director appointed from Pakistan shall be paid 100% in equivalent Pak Rupees.		
<b>Daily Allowance in lieu of House rent allowance</b> (On first arrival for Non-Pakistani nationals)	In the absence of residential accommodation on first arrival per diem of USD 160.00 per day will be paid in lieu of house rent allowance up to a maximum of 21 days for hotel accommodation. An accompanying spouse and up to two of the dependent children below the age of 21 years will be paid 50 per cent of Daily Allowance during this period.		
<b>Residential Accommodation</b>	Unfurnished accommodation within the rental ceiling of <b>US\$ 787.00</b> (US Dollar Seven hundred and eighty-seven) in equivalent local currency of PKR per month.		
<b>Furnishing Grant</b>	One time lump-sum furnishing/settlement grant of US \$ 2,000.00 on arrival.		
<b>Children's Education Allowance</b>	Reimbursement of 90% of school Tuition Fees including Admission, Registration and other compulsory charges subject to an annual ceiling of US\$ 1,500.00 per child for a maximum of two children between the age of 4 to 21 years i.e. children up to Grade XII / A-Level on presentation of actual receipt.		
<b>Medical Allowance</b>	Reimbursement of actual expenses on medical treatment for self, spouse and dependent children subject to an annual ceiling of US \$ 1,500.00.		
<b>Home Leave</b>	Deputy Director appointed from Member States other than Pakistan shall be entitled to Home		

<b>Passage</b>	Leave Passage for Economy class for self, spouse and two dependent children once in their tenure (3 years) after completing 18 months of continuous service.
<b>Emergency Passage</b>	Deputy Director appointed from Member States other than Pakistan shall be entitled to emergency passage once in his/her entire term, in case of death of an immediate family member ( <i>spouse, parents, children and spouse's parents</i> ) of the official.
<b>Telephone</b>	Deputy Director shall be entitled to use telephone at his/her residence, up to USD 20 per month.

- Should be able to work in a mixed culture as part of a team with ability to work under time lines.
- Should have proven background and proficiency in written as well as communicative English.
- Competence in computer use is a requirement with the ability to work independently and to produce result-oriented quality output.
- Unblemished work record.

### **GENERAL INFORMATION:**

- Appointment shall be subject to concurrence (or no objection) from the sending Country through Ministry of Foreign/External Affairs.
- Tenure of the service for the post shall be 03 years. The tenure may be extended, in exceptional circumstance, to a maximum period not exceeding three (03) years, as per applicable SAARC Rules.
- Maximum age limit is 55 years (Age may be relaxed in case of extra ordinary qualification and or regional representative but not exceeding 60 years).
- Only short-listed candidates shall be called for interview.
